- APPLICATION PROCESS FOR INTERESTED PARTIES/POTENTIAL MEMBERS:
- Laura and Kim provided information to Rowan who set up a membership page on the website. <u>ACTION:</u> MEMBERSHIP FORM TO BE CREATED FOR ON-LINE APPLICATION (TO BE E-MAILED TO QTNWG EMAIL ADDRESS) AND HARD COPIES TO BE TAKEN TO MEETING. MEMBERSHIP PAYMENTS WILL HAVE TO BE DEFERRED UNTIL BANKING ARRANGED.

#### • MEMBERSHIP SUBSCRIPTION:

It was agreed that the membership subscription should not be prohibitive to those on low income and set at £10p.a. with donation options for members. Those who can not afford £10p.a. should not be excluded - a form should be available on the website for those who wish to apply for free membership bank details. An error in the previous minutes was corrected - Trustees are not exempt form membership fees. ACTION: AS ABOVE

## • MEETING WITH YEOVIL RIVRS TRUST (YRT):

 Meeting arranged for Feb 16th Thursday 1pm at 9 Springs Cafe (as with YRT previously) <u>ACTION:</u> KIM, EMMA AND LAURA TO ATTEND TO DISCUSS CHARITY APPLICATION; BANKING; FUNDING STREAMS . EMMA TO RECORD MEETING NOTES ON BEHALF OF THE GROUP.

#### CHARITY STATUS:

 The group has agreed that the Charity Status is a palaver which will inevitably take ages and in the meantime there is important work to be done which should not be hampered by lack of charity status. It was agreed that the work, rather than the application process should be priority and the most important thing is to set up a cosignatory bank account so we can accept funding. The charity status application will continue but not as priority <u>ACTION:</u> TO BE DISCUSSED FURTHER AT MEET WITH YRT

#### • BANKING:

• Emma has researched banking options and the favoured account at the moment is 'Unity Trust Business Account'. This needs a minimum initial deposit of £500 and monthly fee of £6. It was agreed by the group that member subscriptions would pay for the banking fees. Emma has begun the application process and reports it being very lengthy. Emma investigated 'Just Giving' page, which is dependent on having a bank account. ACTION: EMMA AND KIM TO LOOK AT THIS AGAIN AFTER MEETING WITH YRT.

## • WATER TESTING EQUIPMENT:

• Kim has set up a QTNWG account with Xylum and has received invoice for equipment. <u>ACTION:</u> KIM TO WRITE FORMAL APPLICATION FOR EQUIPMENT TO BE FUNDED BY PARISH COUNCIL IN ADVANCE OF PARISH COUNCIL MEETING ON 6TH MARCH FOLLOWING DISCUSSION OF POSSIBLE FUNDING STREAMS AT MEET WITH YRT.

## • ON-LINE PRESENCE:

 Rowan has built an excellent website using Hugo Fox. The group agrees a live website and social media platforms are essential for the functioning of the group, particularly in community engagement, newsfeed, and funding. <u>ACTION:</u> ROWAN TO MAKE WEBSITE LIVE, PIN DOWN DOMAIN NAME AND E-MAIL ADDRESS IN ADVANCE OF THE QTNWG PUBLIC MEETING ON 23RD FEBRUARY. KIM TO SEND ROWAN PREVIOUS MINUTES TO ADD TO WEBSITE. SOCIAL MEDIA PLATFORMS TO BE INSTIGATED FOLLOWING WEBSITE GOING LIVE.

## • GROUP NETWORKING:

- Kim and Laura attended the 'Bright Blue Rivers Event' on behalf of QTNWG and Kim spoke. The event was informative and motivational with many other groups and environmental professionals taking part. - Laura has passed on an invitation from Marnhull Green Team to the QTNWG, to attend a meeting, eve of Tues.
